# What changed in how permits were sold between FY25 and FY26

- Permits released:
  - 24-25 Academic Year – Permits became available at 12:00 am.
  - 25-26 Academic Year – Permits became available at 08:00 am.
- Rationale for the Change:
  - In the previous academic year, PTS received substantial feedback that individuals had to stay up to purchase their permit.
  - In the previous academic year, PTS received substantial feedback that there was no customer service to assist them if there were problems.
- Academic year 2025-2026 Adjustments:
  - PTS changed the permit release time to 08:00 am, with the belief it would do the following:
    - Allow PTS staff to provide customer service in the moment, not requiring the customer to wait until P&T opened at 08:00 am.
    - Reduce the complaints that people had to stay up past midnight to compete for a permit.
